This report explores the basics of forest and nature therapy, development of training and certifications to support credentialed practice, and research findings from around the world. The development of forest and nature therapy creates green job opportunities such as forest therapy guides and trainers, research and development roles, certified forest therapy trail implementation, and other associated products and services.

These practices are now being introduced in the United States and Europe and the scientific basis is being expanded, including adoption within the USDA Forest Service. Forest and nature therapy is also being incorporated into treatments prescribed by clinicians. Additional research is necessary to continue to quantify the benefits of these practices and provide an expanded scientific-basis for further adoption.

AltaLink owns and operates approximately 12,500 km of transmission lines and provides electricity transmission services to over 85 percent of Albertans. The company's transmission system includes a diverse array of sustainable energy sources, including wind power, solar and biomass.

Rodale Institute Recognizes Minnesota Farmer, Carmen Fernholz, with a 2022 Organic Pioneer Award

Carmen Fernholz is a family farmer from Madison in western Minnesota and the father of Dovetail Partner's President, Kathryn Fernholz. Carmen and his wife Sally have been farming and advancing organic certification for nearly 50 years. Established in 2011, Rodale Institute's Organic Pioneer Awards honors research scientists, farmers, and business leaders who are leading the movement towards an organic planet.

Over the years, Carmen has served in leadership roles within the University of Minnesota, including for the Minnesota Institute for Sustainable Agriculture, the Regional Sustainable Development Partnership and occupied the Endowed Chair in Sustainable Agriculture Systems. He is currently heading up the establishment of a new farmer coop, Perennial Promise Growers Co-op to assist the University and farmers in growing and marketing new perennial and winter annual crops. He was the first grower to market a certified organic perennial wheat MN Clearwater under the Kernza trademark.

In 2010 he was awarded the Alumni Achievement Award from St. John's University (Minnesota). In 2005 he was honored by Marbleseed (formerly MOSES) as their Organic Farmer of the Year.

He has been honored as Conservation Farmer of the Year in his home county. And in 2015 received the Friend of Agriculture Award from the Minnesota Association of Extension Agricultural Professionals.
